**Subject:** **Recommended Officials - 2019 District 3 Boys Lacrosse Playoffs**

Attached is a form to be used by your chapter to recommend qualified officials to officiate in the 2019 PIAA District 3 Boys Lacrosse Playoffs. A three-man officiating crew will be used for all games. Games are scheduled for the following dates:

<i>First Round</i>	<i>Tuesday, May 14</i>
<i>Quarterfinal Round</i>	<i>Thursday, May 16</i>
<i>Semi-Finals &amp; Consolations</i>	<i>Tuesday, May 21</i>
<i>Finals &amp; Consolations</i>	<i>Thursday, May 23</i>

Recommended officials from your chapter should be submitted in order of chapter ranking, i.e., #1 official being your chapter's top rated official, #2 official your chapter's second top rated official, etc. Your executive committee or a committee designated for the selection process should make chapter recommendations.

The attached form allows your chapter to submit a **specific** number of officials necessary to work these games. Along with the recommended officials, I have asked for alternate officials to be utilized if replacements are necessary. Only submit the number of requested officials, no more or no less.

Playoff assignments will be made through District 3's Boys Lacrosse **Zebraweb** ([www.Zebraweb.com/district3](http://www.Zebraweb.com/district3)) online assigning site. Assignments will be received electronically via e-mail notification. Once I receive each chapter's playoff list (with preferred e-mail contact), I will register each recommended and alternate official. Once registered, officials should log in and include or update their personal information. Closed dates for all officials need to be entered. If you have any questions, please do not hesitate to call me

Please remember the PIAA policy that requires Districts to pay officials by check. **Officials will not receive fee payment at the game site.** The District 3 Treasurer will mail checks to the official's home address approximately two
